## 5. FUNCTION OR USE

#### **Historic Function**

These sites are related to the history of the Vietnam War and US Naval Aviation History and to the history of the town of Searchlight, Nevada. This site is about a Naval Aircraft related to a training mission of the Vietnam War that went down near the area of Searchlight, Nevada. The Naval Aircraft is the P3-A Orion. Eyewitnesses near the site from this area during this era indicated that they had seen signs of the P3-A Orion military aircraft going down via "a lightning flash in a dark cloud followed by burning debris falling to the desert floor." Witnesses reported a violent explosion with an apparent lightning strike. A local foreman at a power plant, Beryl Jarvis, saw the explosion and said, according to a paper, that "the plane just exploded in midair and came down in a fiery crash. It looked like it was hit by lightning " There may still be witnesses alive today in Searchlight, Nevada that witnessed this military aircraft that went down and had been on a training mission during the Vietnam Era. The flight home base of the Aircraft was NAS Barber's Point Hawaii. At 14, 000 feet, near Searchlight, the pilot had radioed in a request and then there was no further contact and the plane was lost from the radar. The wreckage was discovered later

about 1 km South West of Searchlight.

These sites (The Mining Park Entrance of Searchlight and the wreckage nearby) enhance the history of the small historical mining town of Searchlight, Nevada and it's surrounding areas.

This paper references the Mining Park Entrance of Searchlight, Nevada which honors the P3-A Orion that crashed and it's wreckage nearby. There is a rock with a plaque on it at the Searchlight, Nevada Park Mining Entrance. It is the ZULU ECHO SIX MEMORIAL PLAQUE and was arranged and donated by VISTA ROCK in Searchlight, Nevada. The bronze plaque is located on the large boulder at the Mining Park Entrance to the Searchlight Community Center that commemorates the crewmen lost on Flight Zulu Echo Six. The plaque and the airplane structure to the plaque was arranged by Bob McLaughlin. The plaque was done by EAGL FOUNDRY of Utah in Orem, Utah. The airplane sculpture to the plaque was done by Josh Sprague at the Idaho State University Art Department Foundry in Pocatello, Idaho. Captain Brian McGuiness USNR of Clearlake, Washington, reports that Bob McLaughlin of Pocatello, Idaho (a former naval aviator with Patrol Squadron 17) and Carl and Jane Overy, Searchlight residents, initiated creation of the plaque with the help of other town residents Scott Jones, Skip Reindel, Chris Denning, Mike Bolton, Ed Milliren, and "many others who volunteered either materials or their services for free." Reference for all of the above information is Mr. Brian McGuiness.

The P3-A Orion is an antisubmarine warfare aircraft. Many P3A Orion's took part in the Vietnam war. They were used to monitor ship movements around the North Vietnamese coast. By 1979 all of the US Navy P2 Neptune Aircraft had been replaced by the P3 Orion. By the mid 1980's all active duty US Navy Patrol squadrons were equipped with the P3C while the reserve outfits operated with the P3A and P3B. Many P3C Orions saw combat action during Operation Desert Storm. The P3C remains the most up to date version of the P3A. The P-3A, BUNO 152159,was accepted by the Navy in April 1965 and had been flown 3706 hours before it went down. By official report, the most probable cause of the crash was ignition of fuel vapor in the left wing cell by a lightning strike. This reportedly caused the failure of the left wing in flight and the subsequent inflight break-up of the aircraft. The squardon and other related people, however, have some of their own theories to the cause of the crash.

## 8. STATEMENT OF SIGNIFICANCE

**Areas of Significance** 

The wreckage of the P3 is in the High Dessert near Searchlight, Nevada. It is located in the foothills at the eastern base of the McCullough Mountain Range. Altitude of the crash site varies between 4750 and 4400 feet MSL. Per report, when the aircraft crashed it scattered in an eliptical pattern 17,000 feet long by 7000 feet wide. The P3 was assigned to PATROL SQUADRON 17 (VP-17), NAS Barbers Point, Hawaii, and was piloted by LT Timothy D. Bailing, USN. It crashed on Federal Soil Bank Property 30 miles south of Las Vegas on August 3, 1970. The terrain it crashed on consists of sand and rock covered by desert vegetation of yucca trees, various types of cactus and mesquite. Day time temperatures range up to 110 degrees.

Searchlight, which hosts the monument to the crew members that went down with the P3, is a retirement community and small historical mining town about 55 miles south of Las Vegas on Hwy 95. It has a population of about 1. 000 with a 3450 foot elevation. Motels include the El Ray Lodge and the Kay Motel. Searchlight has a general store and a Nugget Casino.

The historic mining town sits fourteen miles up hill from the beautiful Cottonwood Cove on Lake Mohave. The Colorado river forms this breathtaking clear lake out in the middle of the dessert between Las Vegas and Laughlin. Searchlight has a history that includes famous old west names such as Clara Bow, Rex Bell, John Macready, James Cashman, and others. Initial discoveries of gold ore were first made on May 6, 1987. The first claim later became the Duplex mine. The mining district was founded in 1898.

Searchlight began to boom in 1902 and reached it's peak in 1907. By 1919 trains were operating twice a week but a severe wash out in 1923 halted traffic completely. Train service was never restored. In the early 1900's Searchlight was actually larger than Vegas but by 1927 there were only about 50 people remaining. Today searchlight has approximately 800 people and about fifty percent of them are retired. The Searchlight Community Center was dedicated in 1989. The Center houses the Medical Clinic, a branch library, a musuem, an office, meeting rooms, and a kitchen. In Searchlight, there is a post office, senior citizens center, school, and substation. It is the gateway to Lake Mohave and nearby is one of the best large mouth bass fisheries in the west. Of course, there is a trading post and Nugget Casino. Searchlight also has trace element distribution of quartz monzonite stock, a granite type material.

Map showing geographical area of significance, directions, and coordinates to the crash is not released with this application without the permission of the crew member's survivors so as to protect the crash site from 'scavengers.' Release of the information can be considered should the State of Nevada be interested in securing and protecting the area of the crash site. Also, see copy of internet maps provided of Searchlight.

Commissioned at the Officer Candidate School. Served as a Navigation Instructor. Entitled to wear the National Defense Medal, Armed Forces Expeditionary Medal, Vietnamese Service Medal, and the Republic of Vietnam Campaign Medal.

LTJG Henry J. McGreevey, born in Newark, Ohio, December 20, 1944. Entered the Navy in 1968 and was designated a Naval Aviator in 1968. He was a Naval Academy Graduate. He was undergoing instruction for designation as a copilot in the P3 aircraft. Entitled to wear the National Defense Service Medal.

ADJ1 Ambrose Ordonia, born in San Francisco, California November 11, 1937. He was a flight engineer with a total of 3961 flight hours in the P3 aircraft. Entitled to wear the National Defense Medal, Vietnam Service Medal, Vietnam Campaign Medal, Armed Forces Expeditionary Medal, Air Medal Third

Star, Good Conduct Medal Third Star.

ADJ1 Johnny D. Shelton, born 31 October 1932 in Chester, MS. Flight engineer trainee for VP-17. Entitled to wear the National Defense Service Medal, Korean Service Medal, United Nations Service Medal, Good Conduct Medal 2nd Star,

ATN3 Cletus L. Morrison, born 14 September 1946 in Elreno, OK. Attended Oklahoma State University. Entitled to wear the National Defense Service Medal.

AW3 John D. Maas, born 16 July 1949 in Minneapolis, Minnesota. Radar Operator. Entitled to wear the National Defense Service Medal, Vietnam Service Medal, and the Armed Forces Expeditionary Medal (Korea)
